PROMOTION DETAILS

3. The Promotion commences at 12:00 (AEDT) on Friday 19 November 2021 and closes at 11:59pm (AEDT) on Sunday, 9 January 2022 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER

1. DRAW AND PRIZES
